The undersigned is directed—to refer to this Department's O.M. No. 3/1/92-Dir (C), dated the 22nd June, 1998 (copy enclosed) on the subject mentioned above and to inform that the position relating to the ban which was imposed on creation and filling up of posts in the non-statutory departmental canteens/tiffin rooms in the Central Government Offices had been reviewed and after considering the feasibility of arranging office catering through alternative means, it was decided to revoke the ban with immediate effect.
