## Circular No. 35 / 2015-18

The Secretariat meeting of the ITEF (CHQ) was held at Manishinath Bhavan, Rajouri Garden, New Delhi on 5<sup>th</sup> January, 2018 to deliberate upon the following agenda items after paying homage to our departed leaders, Com. Lajpat Royand Com. Samar Bose.

## Agenda 1: Review on Pending demands:

- I. The Recruitment Rules for the cadres of Inspector and Executive Assistant are still pending with DGIT(HRD). In the last PGRC meeting held on 10<sup>th</sup> November, 2017, the Member (Admn.) had directed the DG (HRD) to complete the process and assured us that the RRs will be finalized within two months. However, till date there is no further development on the issue in consonance with our views on the RRs of EA & Inspectors.
- II. Regarding our demand for restoration of Zonal/Regional recruitment of Group C cadres to tide over the huge vacancies, the Member (Admn.) had directed the HRD to examine the proposal and discuss with the Chairman, SSC for a solution. But the matter is still pending with HRD with no progress so far.
- III. In the matter of merger of staff car drivers, the DGIT(HRD) was directed to prepare fresh proposal and send it again to the respective authority for approval. But there is no progress in this matter.
- IV. With regard to the enhancement of the pay of the Casual workers as per 7<sup>th</sup> CPC recommendations, the issue is still pending with DoE. Regarding withdrawal of the order dated 13<sup>th</sup> May 2013, which was principally agreed by the CBDT, a committee has been formed recently to look into it and to take appropriate decisions. The committee has not yet finalized its report.
- V. Clarification was sought from DOPT on the issue of finalization of seniority of the Inspectors of 2009-10 & 2010-11 batches in some regions. It is understood that the DoPT has clarified the matter. The HRD, CBDT will issue necessary instruction thereon.
- VI. In the matter of treatment of advance increments on passing of departmental examinations as per the letter dated 27th May, 2017, the Controller of Accounts [o/o the Pr. CCA, CBDT] had assured in the last PGRC meeting to re-examine it and take action within 15 days of time. Even though continuous persuasion was made no further action has been taken by the CBDT in the matter so far.
- VII. Promotion & DPC: Almost 80% promotion orders in different cadres were issued.
- VIII. ICT issue: without considering our view the HRD issued order dated 04.01.2018.

- IX. For implementation of the CAT, Pr. Bench order regarding re-fixation of pay of Inspectors to 7450/- w.e.f. 1.1.2006, the matter is pending with DoE. As decided in the last Secretariat meeting, a legal notice has been sent to the authority to implement it and we have also filed a caveat petition in the Court.
- X. Re-fixation of pay of Inspectors/AOs/ PSs to Rs.7450/- from 01.01.2006 as per judgment of CAT, Principal Bench: The Deptt. Of Expenditure suggested to the CBDT to go for appeal or writ petition in the High Court. As decided in the last Secretariat meeting held on 11<sup>th</sup> November, 2017, we have already filed Caveat petition in the High Court. It is proposed to collect funds for the purpose to contest in appeal. Hence, It has been decided that initially each circle will contribute Rs.5000 on this account subjected to discussion and decision in the ensuing all India Conference.
- XI. Over time allowance to the SCDs: As per instruction of DoPT, we have requested the CBDT to send the proposal to identify the SCDs as operational staffs for grant of OTA.
- XII. Relaxation in the residency period: it is decided to discuss the issue in the ensuing Conference.
- XIII. Regarding relaxation for promotion to the certain posts in WB & Sikkim charge, the Member (Admn.) has assured again to resolve the matter within a short period of time.
- With regard to re-allocation of Inspector posts to deficient charges (where stagnation is acute), as per decision of the last secretariat meeting a resolution has been submitted to the Member (Admn) on 13th December, 2017 for further examination of this matter.
- XV. In the matter of allocation of sufficient fund in different heads of accounts especially in the medical head, it has decided to send a resolution to the Chairman to look into it and to take necessary action immediately.
- XVI. Regarding the Inter Charge Transfer as per decision of the last secretariat meeting, we have sent our proposal/views, but the HRD without considering to our views in the matter has taken decision unilaterally.

After threadbare discussions, the Secretariat have unanimously decided to organize a half day walkout (from 2 PM) on 30<sup>th</sup> January, 2018 on certain issues mainly on pending RRs. But as per discussion with newly joined Pr. DGIT HRD positively, the walk out out programme postpone upto the ensuing Conference. In the Conference we will discuss about the development of pending issues and will decide next course of agitation programme.

**Agenda 2**. **XXX All India Conference:** Com.Secretary General informed about the number of Delegates entitled (list enclosed) for attending the Conference total of which comes to **197** (on paid up membership). He added that as per the decision on an earlier occasion, the circles are entitled to send, if necessary, observers but limited to 50% of the entitled delegates. The house unanimously accepted his contention of the proposal. It was also decided that the following ex-secretariat members will be invited (retired or promoted) as our guest to attend the inauguration as well as to the open session of the

Com. Yashvant Purohit, Vice President of the ITEF and General Secretary of MP & CG Circle briefly reported the progress in the matter of preparation of the Conference. He requested that participation of number of delegates in the Conference be maintained as per the decisions arrived at in the secretariat meeting. He explained the situation in Ujjain that at that point of time as Shivratri will be falling on 14th February, 2018. Ujjain being a holy city a large number of pilgrims are expected to converge there. Naturally, the situation will bring about pressure on the available infrastructure of that small city. Hence, it may not be possible to arrange extra accommodation during the period. He requested to look into the collection of advertisement for Souvenir to meet up the huge expenditure. Looking into the expenditure involved to conduct the Conference it is proposed that the Delegate (including observers but excluding Advisors/Guests/Sr. leaders) Fees may be fixed to Rs.2000/- The Circle Secretaries are requested to restrict the number of observers to the minimum and their inclusion in the delegation must be with the prior permission from the CHQ. We are constrained to make this request for it would be difficult to arrange decent accommodation at Ujjain during the Sivarathri period.

Com.Purohit also requested all the Circles to send the details of journey of the participating delegates in advance for arrangement of accommodation, transportation etc..

The Secretariat has discussed and decided that the Inauguration of the Conference will be held on 14<sup>th</sup> February 2018 by hoisting the Federation Flag at 10.30 AM sharp and inaugural session will be started from 11.00 AM. The open session will be commencing from 3.00 PM on the same day. All delegates and observers should reach the venue of the Conference by 10 AM on 14<sup>th</sup> February, 2018 positively.
