We have decided to have the flag hoisting programme at 10 AM on 14th February, 2018 followed by the inaugural session and the open session will commence from 3 PM. The host unit has also informed that the accommodation will be available from the 13th to 18th February, 2018. In this connection, we are to invite your personal attention to the requirement of achieving the target of collection fixed for your circles. This you know is the most important pre-requisite for the conduct of the Conference.

All circles are required to remit the Renewal Fees dues by **5th January, 2018** positively (the latest statement of dues of Renewal fee along with tentative no. of delegates is enclosed). **As per the Article IX.A (iv)(a)/(b) of the Constitution, the number of delegates for the All India Conference will be determined on the basis of the paid up membership (Renewal Fees) of the concerned circles. Each circle shall be entitled to depute one delegate for every 200 paid up memberships or part thereof provided the part is 100 or more subject to the minimum of one delegate for each circle.**

In excess of the entitled delegates, the observers are allowed only with the prior approval of the secretariat. All circle secretaries are requested to send their proposal for allowing observers for the ensuing Conference by 5th January, 2018.
