Sub: Resolution on the pending issues of ITEF for immediate attention of CBDT- Regarding.

Kindly refer to our earlier letter dated 22nd September, 2017, there is no such development and no such communication received about status of the pending issues from your good office. Sir, you may know it very well that the Central Working Committee meeting of ITEF was held at Nagpur on 15-16th September, 2017. The meeting inter-alia discussed the inordinate delay in reaching settlement of various issues, which the ITEF had been taking up with the CBDT from time to time. The resolutions adopted on such pending issues were place before your goodself for consideration but maximum issues are still pending with HRD. All the members of the working committee very much appreciated your positive approach towards expeditious actions in the matter and we are very much hopeful about settlement of our long pending issues under your able leadership.

I have been directed by the CWC meeting to appeal before your goodself to issue necessary directions to the concerned authorities to address the following issues immediately, have discussion with the representatives of ITEF and reach settlement thereon without any further delay. The non- settlement of the genuine problems of employees has caused immense discontent and has begun to take the shape of sporadic agitations. It would, therefore, be in the fitness of things that their grievances are addressed to by those in the administration with a sense of urgency and understanding. The failure on the part of administration to act urgently will bring about an avoidable confrontation/litigation and state of agitation.

As per decisions of the CWC meeting, I would like to request you once again to kindly direction may kindly be given to the concerned authority to resolve the following issues within 31st October, 2017 so that the frustration amongst our members does not compel the ITEF to tread the path of agitation and further Industrial action.

Resolution taken on pending Issues in the Central Working Committee meeting held at Nagpur, Maharashtra on 15-16th September, 2017

A. Recruitment/Regularisation & Recruitment Rules:

DGIT(HRD)

- (i) Finalization of pending Recruitment Rules of EA and ITI as per submission of JCA.
- (ii) Restoration of Zonal/Regional Recruitment in the cadre of Gr.-C to tide over the huge vacancies.
- (iii) Regularization of Casual Workers against the MTS posts sanctioned in the cadre restructuring.
- (iv) One time relaxation may be given for appointment on Compassionate grounds.
- (v) Necessary direction may be given to all Pr.CCsIT for filling up of vacant posts in the Departmental Canteens.
- (vi) To conduct review DPC for those retired employees who were eligible for promotion and should have been got promoted, if DPC took place on time.
