(Rupak Sarkar) Secretary General The Secretariat Meeting held on 25.07.2016 at the Manishi Nath Bhawan, New Delhi. After detail discussion the following decisions were taken.

- 1. All the Secretariat members are requested to attend the Conference of the Confederation scheduled to be held on 16th-18th August, 2016 at Chennai. The details of the travel plan may be communicated to Com M.S. Vengetesan, General Secretary, ITEF TN Circle. For smooth organizing the conference, all circles are requested to collect advertisement for souvenir (Forms already distributed) to be published for this programme.
- 2. Regarding 2nd September,2016 strike called by the Central Trade Unions was endorsed by the Confederation in its meeting dated 24th July, 2016. After threadbare discussion it is decided to participate in this strike and mobiles the members. A campaign programme in all State headquarters will be finalized by the Confederation. If required campaign programme may be organised by the ITEF Chq. other than the State Capitals. It is further decided to request the leadership of ITGOA to join with us and participate in the strike. A detailed note will be prepared and to be circulated regarding deferment of 11th July strike and for participating in the 2nd September strike.
- 3. A letter will be issued to ITEF WB Circle Gr.-D regarding the resolution taken by them with a request to attend the CWC meeting for further discussion.
- 4. As per objections given (third times) by the DOPT in the Recruitment Rules of Executive Assistant, Inspector, Admn. Officer and Pvt. Secretary regarding the enhancement of residency period from 3 to 10 years and 3 to 5 years respectively and also to change the quota (DR/PR) for getting the promotion to the post of EA/ITI, a discussion was held and decided to send the copy of objections of DoPT to all Circles for their suggestions. As per suggestions, the proposals will be communicated to the HRD, CBDT for immediate notification of the said cadres.
- 5. As per discussion revised agenda of CWC meeting regarding the phasing out order from West Bengal and reallocation of Inspector posts was issued.
- 6. As per direction of Authority the work related to PAN done by NSDL/UTISL at all ASK centre will be discussed in the Central JCA meeting and decisions will be taken according.

- Detailed discussion will be held in next CWC and will take appropriate decisions regarding merger of Staff Car Driver, relaxation for compassionate appointment and regularisation of casual workers.
- 8. Regarding the promotions for 2016-17 of Group B/C cadres not yet done in some charges. Representatives from JCA was met with Member(P&V) and JS (Admn.) on 25th July, 2016 and they assured us to look into it and will issue necessary instructions within a short period of time.
