- (d) The effective date of passing the Examination shall be governed by this Directorate's Instruction F.No.DE/Delhi/Effective Date/DIT/2011/3886 dated 22.12.2011.[Annex-3].
- (e) The Pr. CCsIT/Pr. CsIT/CsIT (In-charge of Examination) may enroll the candidates for the MS Examination as per the past practice.
