**Sub: Settlement of long Pending issues – in the absence of discussion and negotiation –
Seeking for meeting an early date – Reg.**

May we solicit your kind reference to the brief meeting we had with you on **1st November, 2016** when we called on you on a courtesy visit on your taking over as the Chairman, CBDT. As per discussion we have submitted one letter dated, **2nd Nov.2016** for an early appointment along with some long pending issues and we have also submitted letters dated **9th & 17th November, 2016** intimating pending issues and our decision about demonstration programme scheduled to be organised on 25th November, 2016. We have been informed by your office for a formal meeting to be held today, 23rd November, 2016 at 5 PM. But again we are informed that the schedule meeting has been postponed and date of further meeting not yet finalised and communicated. We need not mention to you, as you have worked in the Department in various capacities that the recognised organizations of more than 90 % workforce are entitled to meet the head of the Department in pursuance of a negotiated settlement of the issues.

We are to inform you that this Federation had always tried to maintain cordial relationship with all your predecessors in office as also at all levels of the administration. We may emphasise the fact that only the active and willing co-operation of the employees, which would come about if they are assured of their grievance being addressed by the Administration, will help the Department to discharge the additional responsibility.

The very purpose of seeking a meeting with you was to bring to your kind notice the frustrating situation where by various Pr.CCsIT and Pr.DGIT(HRD) etc. were not acting upon properly. We regret to note that despite assurances, the various levels of CBDT i.e. ADG(Infra), DGIT (HRD) and some Pr.CCsIT are putting unwanted and unwarranted hurdles causing inordinate delay in resolving the issues.

We are constrained to believe that the authorities of various levels would like to drive us to the path of confrontation and create an unavoidable situation. We have thereafter decided to commence our deferred agitational programme as under:

The members of Income Tax Employees Federation all over the country will organise Dharna with a Demonstration on 25th November, 2016 (Friday) from 11 AM to 2 PM in front of the office of Pr.DGIT(HRD) CBDT and in front of the office of all Pr.CCsIT to protest against the inordinate delay and the reluctant/negative attitude of the authorities in resolving the long pending issues.

We once again request you to kindly spare some time even it is on Saturday or Sunday as suggested by you on 1st November, 2016, when we met you, and inform accordingly, so as to maintain cordial atmosphere and to avoid unwanted agitation.
